This is not for the one who wants to show how much they know, but for the ones that are willing to go the extra mile while exhibiting proper spiritual and character traits.

Proficient in being able to share his or her faith and demonstrate that in and out of the dojo. They would have a servant's heart, good character, spiritual maturity and set the example for others in the class. They also need to be able to grasp material clearly and relay it correctly.

Under direct supervision of a GMAU instructor (at least full instructor level)

Understands he/she may be relieved of this position at any time by the dojo leadership upon a lapse of character or teachable spirit.

Once appointed, it is expected that the student would continue to prepare his or her skills and academic understanding such that once they earn their 2nd Kyu/Gup (brown belt), they would be able to test for the GMAU Assistant Sensei rating.

Specific tasks may include but are not limited to:

greet newcomers to the class, make the necessary introductions and get them oriented to the class routine and basic etiquette

lead portions of the class warm-up drills

be responsible for teaching lower belt levels during kata, basic drills or one-step segments of the class

be responsible for cleaning the dojo, setting up the equipment for class and resetting the dojo after class.
